ACKNOWLEDGEMENTS

As a Candidate for Emperor or Empress, I hereby acknowledge the following:

1. Applications must be received in the organization's post office box and postmarked on or before June 1st.
2. The Candidate Review Board as specified in the operating procedures will review applications. All persons submitting an application must attend the June meeting of the Candidate Review Board for the purpose of application review. Failure to appear without Board approval will void the application.
3. Falsification of any information disclosed on any application document will result in rejection of the application.
4. No campaigning is allowed within one (1) block of the voting area, however one (1) campaign poster is allowed in the voting location.
5. Each candidate must participate, as a candidate, in at least one Board of Director's sanctioned event, and the candidate must participate in the Candidate Show. At the candidate show each candidate is required to read a written speech about themselves up to five minutes in length followed by a question and answer period. The speech must be presented to the Candidate Review Board no later than seven (7) days prior to the Candidate Show. Participation in more than one event is encouraged.
6. The final vote tally authorized by the Election Committee is final. No recount of votes is allowed.
7. The IWCCPSE will not be responsible to uphold any promise or commitment made by a candidate to any other individual or organization as it relates to the candidates campaign.
8. As candidates of the IWCCPSE campaign functions are considered to be benefits for charity, therefore all proceeds from campaign functions shall be turned over to the Treasurer. The Board of Directors will have the final decision on the distribution of said proceeds.
